The Adjunct Faculty (APO) is responsible for developing curriculum and presenting instruction in subject areas. Payment method for employees assigned to this job is "APO, lump-sum, fee-for-service."

MINIMUM QUALIFICATIONS

Bachelor's degree in Engineering, Engineering Technology or other Applied STEM discipline from a regionally accredited college or university.

PREFERRED QUALIFICATIONS

- Professional Engineer (PE) license or Master's degree in Engineering o related field.
- Minimum of three (3) years' industry experience in automation, process instrumentation or process control.
- Experience teaching at the postsecondary level or in industry.

COMPETENCIES

Experience and knowledge of electric machines, motor control systems, and programmable logic controllers (PLCs). Participation in appropriate professional/occupational organizations, supervisory experience, excellent human relations skills, and excellent written and verbal communication skills.

MAJOR DUTIES

- Teach Instrumentation and Control Systems Engineering Technology (ICET) course(s) based on schedule needs.
- Utilize instructor guidebooks for assigned course(s), which contain course outlines, lesson plans, information sheets, remedial and enrichment activities, a list of audiovisual materials and computer software available, and copies of evaluation instruments or a written statement as to where they are located.



- Use a syllabus for each assigned course that contains the name and number of the course, a course description, the assignment schedule, a list of the student learning outcomes, the required textbooks, required tools and supplies, the evaluation, and grading procedures.
- Establish a safe environment conducive to learning in the classroom and/or laboratory.
- Prepare for class by working with the department head, program director, lead instructor, or director of academic affairs to select appropriate learning experiences as evidenced by the following: updating instructional materials such as handouts, syllabi, ordering supplies; reproducing of materials; and using a variety of learning modalities including instructional technology to augment instruction.
- Maintain course content that is current, well organized, and related to course objectives and to student's previous learning. Demonstrate knowledge in the following areas: institutional services and policies, library resources, and bookstore operations.
- Complete and submit required rosters, attendance documentation, and grades in a timely manner.
- Demonstrate excellent written and oral communication skills.
- Maintain control of class during instruction as well as handles disruptions in the classroom/lab. All discipline handled in a dignified manner.
- Demonstrate respect for students as individuals.
- Demonstrate accessibility in dealing with students' needs both individually and as a group, and communicates clearly to students.
- Demonstrate excellence in instructor performance as reflected by the majority of positive responses on student evaluations.
- Counsel students with grades and attendance problems, refers students to tutoring and the counseling center, if needed.
- Perform other related duties as assigned.
