JOB SUMMARY

The **Administrative Assistant II to the School of Business, Cyber & Design** is responsible for providing administrative support for the operations of the Division under the direction of the school's Dean.

MINIMUM QUALIFICATIONS

- Associate's degree in Business Administrative Technology **and** one (1) year of work-related experience
- OR**
- A high school diploma **and** two (2) years of related work experience

PREFERRED QUALIFICATIONS

- Two or more years of related experience, preferably in the academic business, cyber and design environment.
- Proficient in Microsoft Office and keyboarding at least 55 words per minute

MAJOR DUTIES

- Reports to and assists the Dean with managing departmental operations for the School of Business, Cyber, and Design on the main campus, as well as at the GA Cyber Center
- Greet visitors and direct them to the appropriate person or office. Answer and screen telephone calls, record messages accurately, and respond to telephone inquiries.
- Provides administrative assistance and support for faculty and maintains electronic academic records
- Assists with student advisement and registration for the individual programs
- Prepares and maintains payroll, submits monthly payroll reports, and prepares contract addenda, ACA reports, and employment agreements
- Proficient in Banner computer software skills for the input of course offerings, student registration, generating academic reports, etc.
- Assists with data collection and reporting
- Will foster effective cooperation, coordination, and communication across multiple campuses and departments with regard to academic programs and student needs
- Performs other duties as assigned by the Dean
