Augusta Technical College, a unit of the Technical College System of Georgia, is a two-year college located in Augusta, Georgia. JOB SUMMARY

The **Director of Finance** is responsible for the administration, development, and implementation of initiatives, supervision of employees, as well as management of staff and the comprehensive accounting and financial activity of the technical college.

MINIMUM QUALIFICATIONS

Bachelor's degree in Accounting, public administration, or a closely related field from an accredited college or university in an area related to the assignment, and three years of full-time work experience.

PREFERRED QUALIFICATIONS

A master's degree in accounting or a closely related field and at least five years of full-time, paid work experience within the past five years is also desired. Functional knowledge of the Georgia TeamWorks Financial System, Workday Financial System, and Banner Student Accounts system. Experience in governmental accounting and GAAP.

COMPETENCIES

Must possess effective communication and decision-making skills as well as problem-solving.

MAJOR DUTIES

- Serves as subject matter expert or organization resource in assigned areas.
- Manages and assists with developing a comprehensive accounting program, which integrates Generally Accepted Accounting Principles (GAAP), Governmental Accounting Standards, statutory accounting requirements, and departmental fiscal policies and procedures.
- Trains, assigns, and directs the work of assigned personnel while providing guidance.
- Supervises personnel in areas involving financial and accounting operations.
- Communicates best practices.
- Conducts regular evaluation of services provided and makes adjustments as needed.
- Facilitates general accounting functions, including accounts receivable, accounts payable, asset management, purchasing, account reconciliation, and cash management.
- Reviews and analyzes financial records for accuracy.
- Compiles and submits various reports internally and externally.
- Maintains proper internal controls and reviews account balances for accuracy.
- Understands and applies state and federal regulations.
- Assists with year-end closing procedures, including financial statement preparation.
- Assists with budget development.
- Submits financial reports as requested in a timely manner.
- Develops and/or assists with the development of policies and procedures and recommends changes to effectively meet the goals and requirements of the department.
- Correctly identifies discrepancies in financial records and takes appropriate corrective action(s) to amend identified variances.
- Analyzes financial statistics and other accounting data to identify trends impacting the fiscal position of the technical college.
- Maintains knowledge of assigned program area and gives updates to management on services, operations, and projects.
- Represents the financial interests of the technical college in accounting related interactions with other parties, such as banks, vendors, auditors, and external customers.
- Other duties as assigned.
