The **Student Affairs Admissions Assistant** is responsible for performing administrative and clerical duties in support of the Student Affairs Program.

MINIMUM QUALIFICATIONS

A high school diploma or high school equivalency and at least 2 years of full-time related work experience are required.

PREFERRED QUALIFICATIONS

A credential in Business Technology or a closely related field from an accredited postsecondary college or university is strongly preferred. At least 1 year of full-time related work experience required.

COMPETENCIES

Must demonstrate strong technology and computer applications skills, customer service, organizational skills, and verbal and written communication skills. Flexibility of travel if necessary.

- Processes applications for admissions from initial contact to acceptance.
- Assists with campus tours.
- Responds to incoming leads and other inquiries through the website or other marketing efforts.
- Receives phone calls and provides information and guidance as needed; greets applicants, visitors, and students, and refers special cases to the Assistant Director of Admissions.
- Inputs and images pertinent data for each application.
- Schedules and notifies applicants for admissions placement testing as needed.
- Verifies that applicants have met admissions requirements for entry into chosen program or course and notifies applicants regarding acceptance, registration, etc., by sending appropriate correspondence.
- Assists with new student orientation and registration each term.
- Generates computer reports for admissions processing as needed.
- Performs other duties as assigned as assigned.

As a part of the application process, interested candidates will be required to upload other documents including a resume, cover letter, and unofficial transcripts (see job center listing for more details). Some positions may additionally require a motor vehicle record search, credit history check, fingerprinting, and/or drug screen.
