JOB SUMMARY

The **Student Affairs Assistant in Admissions** is responsible for performing customer service and administrative duties associated with the enrollment process.

MINIMUM QUALIFICATIONS

A high school diploma or high school equivalency and at least 2 years of full-time related work experience are required.

PREFERRED QUALIFICATIONS

A credential in Business Technology or a closely related field from an accredited post-secondary college or university is strongly preferred. At least 1 year of full-time related work experience is required.

COMPETENCIES

Must demonstrate strong technology and computer applications skills, customer service, organizational skills, and verbal and written communication skills. Flexibility of travel if necessary.

MAJOR DUTIES

Processes applications for admissions from initial contact to acceptance. Assists with campus tours. Responds to incoming leads and other inquiries through the website or other marketing efforts. Receives phone calls and provides information and guidance as needed; greets applicants, visitors, and students and refers special cases to the Assistant Director of Admissions. Inputs and images pertinent data for each application. Schedules and notifies applicants for admissions placement testing as needed. Verifies that applicants have met admissions requirements for entry into chosen program or course and notifies applicants regarding acceptance; registration, etc., by sending appropriate correspondence. Assists with new student orientation and registration each term. Generates computer reports for admissions processing as needed. Performs other duties as assigned as assigned.

APPLICATION DEADLINE: The position will remain open until filled. As a part of the application process, interested candidates will be required to upload other documents including a resume, cover letter, and unofficial transcripts (see job center listing for more details). This posting will be removed from the Online Job Center once the position has been filled. All positions require a pre-employment criminal background investigation, education, and employer/professional reference checks. Some positions may additionally require a motor vehicle record search, credit history check, fingerprinting, and/or drug screen. All male applicants between the ages of 18 and 26 years of age must present proof of Selective Service Registration. Copies of all transcripts should be submitted at the time of application.
