**Position:** Aviation Maintenance Instructor

**Employment Status:** Full Time

**Application Deadline:** September 26, 2019

**Projected Start Date:** Fall Semester

### Position Summary:

Under general supervision, provides instruction to students in aviation maintenance courses. Demonstrates the use of appropriate teaching techniques, testing and grading procedures, effective use of oral and written communication skills, and knowledge of current in-field procedures. Follows approved course syllabus. Maintains program requirements, professional development training, and industry standards. Evaluates student progress. Participates in student advisement and registration. Maintain qualifications for employment as described by the Technical College System of Georgia (TCSG) Policy Manual and accreditation standards. Position may involve teaching traditional day and/or evening classes or and may require travel to any of the satellite locations within the College's service area.

### Projected Work Hours / Location:

This position is projected to work the College's normal business hours of 7:45 a.m. to 4:45 p.m., Monday through Thursday, and 7:45 a.m. to 3:30 p.m. Fridays. Position may involve teaching evening and/or online classes as needed. Position will be located at the Middle Georgia Regional Airport with travel to the Warner Robins campus and other instructional locations as needed. This position will work 12-months per year and 40 hours per week.

### Minimum Qualifications:

- Current FAA Airframe and Powerplant license and,
- Postsecondary certificate in Aviation Maintenance or related field from a regionally accredited institution with at least three (3) years documented paid full-time, in-field work experience to include competencies, skills and knowledge levels in the aviation maintenance and aircraft structural technology instructional program

**-OR-**

- Earned High School Diploma or earned equivalent with a documented minimum of seven (7) years paid work experience in-field within the past ten (10) years and,
- Current FAA Airframe and Powerplant license for at least ten (10) years

### Preferred Qualifications, in addition to minimum qualifications:

- Earned Associate's Degree or higher in Aviation Maintenance or related field from a regionally accredited institution
- Documented teaching experience in aviation program

**Salary/Benefits:**

Target annual gross salary is upper \$40s to low \$50s. Actual salary will be determined by the candidate's highest qualifying degree level and related work experience. This is a fulltime position scheduled to work 12-months a year and 40 hours per week. Position is eligible for state benefits to include insurance, leave accrual, retirement and holiday pay. CGTC is a member of Teachers Retirement System of Georgia (TRS) and Employees Retirement System of Georgia (ERS).

**APPLICATION PROCEDURE:**

All applications and supporting documents must be submitted online by the posted deadline via the Central Georgia Technical College Job Center. A completed application packet consists of the following:

- A completed CGTC online application
- Postsecondary transcripts that demonstrate the applicant meets the educational minimum requirements and, if applicable, the preferred educational requirements
- Positions requiring a High School Diploma or GED as a minimum qualification do not have to submit transcript documentation as part of the application process
- Non-photo license(s) and/or certification(s) which fulfill the requirements of the position

Unofficial transcripts are accepted to the extent that they indicate that the degree or credential was earned/conferred; grade reports and diploma copies are not accepted in lieu of transcripts. Educational credentials, degrees, or coursework cannot be considered without transcripts. Incomplete application packets at the time of the position closing may not be considered. It is the responsibility of the applicant to obtain and upload the application documentation by the stated deadline.
