Position: Clinical Laboratory Technology – Clinical Coordinator

Application Deadline: June 25, 2018

Employment Status: Full Time

Position Summary:

Under general supervision, the Clinical Laboratory Technology Clinical Coordinator is responsible for planning, organizing, and teaching courses in the CLT program as well as instructing in the clinical setting. The clinical coordinator will work with clinical sites to build and maintain relationships, maintain clinical contracts, and place students in the clinical setting. The clinical coordinator will work to assure validity of curriculum in meeting State and NAACLS standards, writes and document fulfillment of program policies and procedures. Demonstrates the use of appropriate teaching techniques; use of appropriate testing and grading procedures including proper maintenance of grade books and any other record-keeping required; effective use of oral and written communication skills; and knowledge of current in-field procedures. Follows approved course syllabus. Maintain program requirements, attend/complete all professional development training; meet with students and college personnel to discuss students' instructional programs and other issues. Evaluates student progress in attaining goals and objectives. Completes all reports, records and invoices in a timely manner and maintains accurate inventory of all assigned properties. Maintain qualifications for employment as described by the Technical College System of Georgia (TCSG) Policy Manual and accreditation standards. Follows rules and regulations as described by the TCSG Policy Manual and other policies and procedures established by the institution. Position may involve teaching traditional day and/or evening classes or online classes and will require travel to any of the satellite locations within the College's service area.

Projected Work Hours / Location:

This position is projected to work the College's normal business hours of 7:45 a.m. to 4:45, Monday through Thursday, and 7:45 a.m. to 3:30 p.m. Fridays. Actual work hours will be adjusted to accommodate clinical settings needs. Position will be located at the Warner Robins campus with travel to assigned clinical sites required and to other college campus locations as needed.

Minimum Qualifications:

- Associate's degree from a regionally accredited institution; graduation from an CLT/MT program
- ASCP certification, MT
- 3 years' experience in field as a technician

Preferred Qualifications, in addition to minimum qualifications:

- Post-secondary teaching experience

Salary/Benefits:

Target salary is mid \$40s. Actual salary will be determined by the candidate's highest qualifying degree level and related work experience. This is a fulltime position scheduled to work 12-months a year and 40 hours per week. Position is eligible for state benefits to include insurance, leave accrual, retirement and holiday pay. CGTC is a member of Teachers Retirement System of Georgia (TRS) and Employees Retirement System of Georgia (ERS).

APPLICATION PROCEDURE:

All applications and supporting documents must be submitted online by the posted deadline via the Central Georgia Technical College Job Center. A completed application packet consists of the following:

- A completed CGTC online application
- Current Resume or CV that outlines qualifications that demonstrates the applicant meets the minimum qualifications and if applicable, the preferred qualifications of the position
- Postsecondary transcripts that demonstrate the applicant meets the educational minimum requirements and, if applicable, the preferred educational requirements
- Positions requiring a High School Diploma or GED as a minimum qualification do not have to submit transcript documentation as part of the application process
- Non-photo license(s) and/or certification(s) which fulfill the requirements of the position

Unofficial transcripts are accepted to the extent that they indicate that the degree or credential was earned/conferred; grade reports and diploma copies are not accepted in lieu of transcripts. Educational credentials, degrees, or coursework cannot be considered without transcripts. Incomplete application packets at the time of the position closing may not be considered. It is the responsibility of the applicant to obtain and upload the application documentation by the stated deadline.
