Job Responsibilities:

Under general supervision, provides instruction to students in cardiovascular courses. Demonstrates the use of appropriate teaching techniques; use of appropriate testing and grading procedures including proper maintenance of grade books and any other record-keeping required; effective use of oral and written communication skills; and knowledge of current in-field procedures. Follows approved course syllabus. Maintain program requirements, attend/complete all professional development training; meet with students and college personnel to discuss students' instructional programs and other issues. Evaluates student progress in attaining goals and objectives. Completes all reports, records and invoices in a timely manner and maintains accurate inventory of all assigned properties. Maintain qualifications for employment as described by the Technical College System of Georgia (TCSG) Policy Manual and accreditation standards. Follows rules and regulations as described by the TCSG Policy Manual and other policies and procedures established by the institution. Position may require travel within the college's service area as well as other travel as required.

Projected work Hours / Location:

This position is projected to work the College's normal business hours of 7:45 a.m. to 4:45 p.m., Monday through Thursday, and 7:45 a.m. to 3:30 p.m. Friday's. Position will be located on the Macon Campus. May require travel to other assigned college locations as well as travel as needed. This is a fulltime position scheduled to work all 12 months per calendar year and at 40 hours per week.

Minimum Qualifications:

- Associate of Applied Science Degree in Cardiovascular Technology or a related field from a regionally accredited institution.
- Documented 2 to 4 years of Diagnostic and Interventional Cardiac Catheterization experience to include the following: Cath Lab radiographic and specialty equipment and procedures, diagnosis and treatment of heart disease, heart rhythm interpretation, and other modalities and procedures such as open-heart surgery, electrophysiology, echocardiography and cardiac rehabilitation.
- Current Registered Cardiovascular Invasive Specialist (RCIS) credential

Preferred Qualifications, in addition to minimum qualifications

- Bachelor's degree in the teaching discipline from a regionally accredited institution
- Teaching experience at the postsecondary level/prior teaching experience in cardiovascular technology

Salary/Benefits:

Target salary is mid \$40's. Actual salary will be determined by the candidate's highest qualifying degree level and related work experience. This is a full-time position scheduled to work 12-months a year and 40 hours per week. Position is eligible for state benefits to include insurance, leave accrual, retirement and holiday pay. CGTC is a member of Teacher's Retirement System of Georgia (TRS) and Employee's Retirement System of Georgia.

- Positions requiring a High School Diploma or GED as a minimum qualification do not have to submit transcript documentation as part of the application process
- Non-photo license(s) and/or certification(s) which fulfill the requirements of the position
