Position: Diesel Truck Maintenance Technician Instructor

Application Deadline: Open Until Filled

Employment Status: Full Time

Position Summary:

Under general supervision, provides instruction to students in Diesel Truck Maintenance courses. Demonstrates the use of appropriate teaching techniques, testing and grading procedures, effective use of oral and written communication skills, and knowledge of current in-field procedures. Follows approved course syllabus. Maintains program requirements, professional development training, and industry standards. Evaluates student progress. Participates in student advisement and registration. Maintain qualifications for employment as described by the Technical College System of Georgia (TCSG) Policy Manual and accreditation standards. Position may involve teaching traditional day and/or evening classes or and may require travel to any of the satellite locations or sites within the College's service area.

Projected Work Hours / Location:

This position is projected to work the College's normal business hours of 7:45 a.m. to 4:45 p.m., Monday through Thursday, and 7:45 a.m. to 3:30 p.m. Fridays. Position will be assigned to the Peach County Workforce Development Center with travel within the college's service area as needed. This is a fulltime position scheduled to work 12-months a year and 40 hours per week.

Minimum Qualifications:

- High School Diploma or equivalent
- ASE certifications in the instructional areas
- Documented three (3) years paid, in-field work experience to include competencies, skills and knowledge levels in the instructional program

Preferred Qualifications, in addition to minimum qualifications:

- Post-secondary teaching experience
- Post-secondary credential in diesel mechanic or related field from a regionally accredited institution

The instructor should be able to accomplish all physical activities required of the general workforce in the technical area of teaching Diesel Technology, including:

- Physically and safely, on a regular basis, lift diesel items weighing 10 to 20 pounds
- Occasionally lift diesel items weighing up to 50 pounds – i.e. tires and wheels
- Be able to manipulate diesel equipment safely onto a lift or other equipment used in the diesel lab weighing from 500 to 1,000 pounds
- Perceive spatial awareness – be able to see conditions that may present a dangerous environment – glasses or corrected vision allowed
- Be able to visually perceive objects – glasses or corrected vision allowed
- Physically respond to any dangerous condition quickly

- Physically work in an environment with variable temperatures – includes classroom, lab or parking lot
- Physically stand on your feet for at least 15 minutes an hour without a break
- Physically bend at the knees and hold an object at the same time – be able to adjust the service rack before the bike is lifted
- Physically bend at the waist – be able to bend over and pick-up objects (parts) from the floor

Salary/Benefits:

Target annual gross salary is low to mid \$40's. Actual salary to be determined by the candidate's highest qualifying degree level, ASE certifications and related work experience. This is a fulltime position scheduled to work 12-months a year and 40 hours per week. Position is eligible for state benefits to include insurance, leave accrual, retirement and holiday pay. CGTC is a member of Teachers Retirement System of Georgia (TRS) and Employees Retirement System of Georgia (ERS).

APPLICATION PROCEDURE:

All applications and supporting documents must be submitted online by the posted deadline via the Central Georgia Technical College Job Center. A completed application packet consists of the following:

- A completed CGTC online application
- Current Resume or CV that outlines qualifications that demonstrates the applicant meets the minimum qualifications and if applicable, the preferred qualifications of the position
- Postsecondary transcripts that demonstrate the applicant meets the educational minimum requirements and, if applicable, the preferred educational requirements
- Positions requiring a High School Diploma or GED as a minimum qualification do not have to submit transcript documentation as part of the application process
- Non-photo license(s) and/or certification(s) which fulfill the requirements of the position

Unofficial transcripts are accepted to the extent that they indicate that the degree or credential was earned/conferred; grade reports and diploma copies are not accepted in lieu of transcripts. Educational credentials, degrees, or coursework cannot be considered without transcripts. Incomplete application packets at the time of the position closing may not be considered. It is the responsibility of the applicant to obtain and upload the application documentation by the stated deadline.
