



Industrial Technology Instructor Part-time Whitfield Murray Campus

Georgia Northwestern Technical College (GNTC) is seeking qualified applicants for the part-time position of Industrial Technology Instructor housed on the Whitfield Murray Campus.

Industrial training instructors are needed with at least ONE of following areas of expertise:

1. Robotics skills in at least one of the following areas:
 - a. Programming on any major robotics platforms (ABB, Fanuc, Motoman, etc.)
 - b. Mechanical maintenance and repair on any of the major robotics platforms.
 - c. Work cell design.
 - d. Systems integration
2. PLC skills in at least one of the following areas:
 - a. Wiring on any PLC platform
 - b. Programming on any PLC platform
 - c. Troubleshooting
 - d. Integration and networking
3. VFD wiring, programming, and communication protocols (any platform).
4. General industrial electrical skills in at least one of the following areas:
 - a. Industrial motors
 - b. Electrical panel building
 - c. Electrical theory
 - d. NFPA 70 and/or 70E
 - e. Conduit bending and hanging
 - f. Controls
 - g. Instrumentation
5. General industrial mechanic skills in at least one of the following areas:
 - a. Pumps and Piping
 - b. Shafts and alignments
 - c. Mechanical drives
 - d. Welding
6. Drafting and design
 - a. Sketching
 - b. CAD on any major platform (AutoCAD, SolidWorks, etc.)
 - c. CAM software (any platform)
7. Industrial Safety, all topics needed, including:
 - a. Arc Flash
 - b. Confined Space
 - c. LOTO
 - d. Lift Truck
 - e. Fall Protection
 - f. HAZMAT
8. Fabrication
 - a. Layout

- b. Welding (all processes)
 - c. Machine tool (mill, lathe, etc.)
 - d. Precision measurement
 - e. CAM software (any platform)
 - f. Conversational programming.
9. Networking, all topics

Duties/Responsibilities:

- Provides professional instruction based on approved course syllabus. Ensures that desired course outcomes meet the stated objectives;
- Prepares curriculum and syllabus for coursework taught;
- Evaluates students' progress in attaining goals and objectives;
- Administers and grades class examinations;
- Maintains records of student attendance and grades;
- Attends in-service training, workshops and seminars, as needed;
- Maintains program certification requirements;
- Ensures safety and security requirements are met in the training areas;
- Assists with recruitment, retention and job placement efforts;
- Meets with students, staff members, supervisors, as needed;
- Other duties as assigned.

Competencies:

- Skill in developing lesson outlines and materials
- Knowledge of vocational area of assignment
- Skill in presenting subject matter
- Skill in administering tests to evaluate progress
- Skill in the use of computers and job related software programs
- Skill in interpersonal relations and in dealing with adult learners

Required Qualifications: For all areas, manufacturer specific training or certifications are desired, but not required. A minimum of two years' work experience in related field and/or an associate degree. Recent retirees are encouraged to apply.

Preferred Qualifications Certificate level or higher education in a related field. Experience as an instructor at the post-secondary level. Course work or work experience in curriculum development, instructional methods, and instructional assessment.

Physical Demands:

Work is typically performed in a classroom or office environment with intermittent sitting, standing, or walking in various settings. The employee occasionally lifts or moves objects to a light to medium weight. Full range of hand and finger motion may be utilized for data entry purposes. If the job involves driving, physical requirements include the ability to operate a vehicle and sit for extended periods.

Salary: paid by lumpsum semi-monthly based upon contact hours

Benefits:

If this is a part-time position, no benefits are available. If this is a full-time position, benefits include: 13 paid State holidays, annual and sick leave, a State of Georgia benefits package that includes Health, Dental, Vision, Life, etc. A choice of two retirement systems: Teachers Retirement System of Georgia or the Employee's Retirement System of Georgia based upon position and 401K options.
