## DESCRIPTION

Under general supervision, the NA Instructor will provide theoretical and clinical instruction to both college and high school students in the Nurse Aide Program at Oconee Fall Line Technical College. Provides instruction to students in nurse aide and allied health core courses. Prepares lesson plans, evaluate students' progress, and maintains program certifications as needed. Demonstrates knowledge of current in-field procedures. The NA Instructor will report directly to the Director of Nursing. Position may involve day and evening hours and may require travel to other campus locations.

### MINIMUM QUALIFICATIONS

Applicant must be a Registered Nurse (RN) in good standing with the Georgia Board of Nursing with minimum of an Associate Degree in Nursing. One (1) year nursing experience.

**PREFERRED QUALIFICATIONS:** Bachelor's degree in nursing from an accredited college or university. Instructional experience including Nurse Aide Train the Trainer.

Knowledge of the mission of postsecondary vocational/technical education. Knowledge of college purchasing policies & procedures. Knowledge of academic course standards, faculty credential requirements. Decision making and problemsolving skills. Operation of computers & job-related software.
