Maintenance Worker

CAMPUS: Sandersville

STATUS: Part-Time/Non-Exempt

DUTIES: Under general supervision performs basic custodial and maintenance duties including: occasionally unlocking campus buildings in the morning; collecting trash and debris for disposal; maintaining, repairing, moving furniture as needed; changing filters and lightbulbs; occasional lawn care.

MINIMUM QUALIFICATIONS: High school graduate or GED equivalency. Must possess a valid driver's license.

COMPETENCIES: Knowledge of grounds keeping. Knowledge of the operation, maintenance and repair of grounds maintenance equipment. Skill in the operation of assigned vehicles and equipment. Skill in the analysis of problems and the implementation of solutions. Oral and written communication skills. Ability to read and follow instructions. Ability to lift up to 40 pounds regularly.

SALARY/BENEFITS: \$15.00 per hour. Maximum 19 hours per week.
