Practical Nursing Instructor

STATUS: Full-time (Exempt)

DUTIES: Under general supervision, the Practical Nursing Instructor will provide theoretical and clinical instruction to students in the Practical Nursing Program at Oconee Fall Line Technical College. Demonstrates the use of appropriate teaching techniques; demonstrates the use of appropriate testing and grading procedures including proper maintenance of grade books and any other appropriate record-keeping required; demonstrates the effective use of oral and written communication skills; demonstrates knowledge of current in-field procedures. The PN Instructor will follow approved course syllabus, complete all reports, record and process invoices in a timely manner. PN Instructor will maintain an accurate inventory of all assigned properties. Position may involve day and evening hours and may require travel to other campus locations.

MINIMUM QUALIFICATIONS: Associate degree in nursing is required. Applicant must hold a current Georgia Registered Nurse (RN) license in good standing and have a minimum of 3 years practice as a licensed registered nurse within the preceding 7 years.

COMPETENCIES: Work experience must include the competencies, skills and knowledge levels required for the subject matter being taught. Must demonstrate effective written and verbal communication skills. Must possess and maintain appropriate professional credentials required for or related to field. Experience as an instructor/teacher in a secondary or postsecondary setting is preferred.

SALARY/BENEFITS: Salary is commensurate with education and experience. Benefits include state holidays, annual, personal, and sick leave, State of Georgia Flexible Benefits and State Health Benefit Plan.
