Under general supervision, will provide instruction to students at the Coffee Campus in Air Conditioning Technology courses. Demonstrates use of appropriate teaching techniques. Demonstrates the use of appropriate testing and grading procedures including proper maintenance of grade books and any other appropriate record-keeping required. Understands and is experienced in operating, troubleshooting, and repairing equipment in the air conditioning field. Follows appropriate course syllabi. Completes all documentation related to assigned courses in a timely manner and maintains an accurate inventory of all assigned property. Courses will be primarily for night classes; may include some day classes depending on the availability of applicant.

Diploma in the teaching discipline (heating, ventilation, air conditioning, refrigeration) with verifiable credentials, qualifications, or competencies appropriate for teaching the course content.
