To include but not limited to observation of GaTAPP candidates in a classroom environment; teach and assess, both formally and informally, the concepts and skills included in the Essentials of Effective Teaching course and in program Saturday seminars; evaluate unit/lesson plans and give feedback to candidates using unit plan evaluation forms; review documentation of portfolios; provide training for GaTAPP mentors; provide input concerning candidates' strengths and deficiencies and make suggestions for remediation; provide assistance to GaTAPP candidates as requested or as determined by the CST; and assist in the assessment of courses, candidates, and GaTAPP processes. Must be able to observe GaTAPP candidates during the day, Monday-Friday. Must demonstrate knowledge of current trends in education, pedagogy, and academic language.

MINIMUM QUALIFICATIONS

MEd or participation in a graduate program from an accredited college or university; valid State of Georgia teaching certificate; minimum of five years successful teaching experience; excellent verbal, written, interpersonal and organizational skills are a must. Must possess effective computer skills utilizing Microsoft Word, Microsoft Excel, and Internet-based platforms.
